CALL FOR PAPER: The Jahangirnagar Review (Social Science), Vol. 48, 2024

The Jahangirnagar Review (Part II, Social Science) is a peer reviewed high quality journal that is focused on the issues in Social Sciences. The journal welcomes theoretical, empirical and original research papers from designated academicians, professionals and researchers from home and abroad. Authors are requested to send a hard copy and soft copy (MS Word rich text format) of manuscript along with the Plagiarism/Similarity Check Report (a text similarity below 20% is acceptable) to deansoci@juniv.edu by August 31, 2023.

Guidelines for Manuscripts Submission

Manuscripts should be typed in double-spaced, with ample margins and no more than 5000 words. The first page should bear the title of the contribution, the names and the affiliations of the all contributors and full postal address together with the email address and contact number of the corresponding author. The second page should include the title followed by an abstract main text should be followed by acknowledgements, endnotes and references. Excessive endnotes to the texts should be avoided.

Figures and Tables: Authors should supply clear copies of original artwork (figures) for illustrations, in a finished format suitable for reproduction. Please note that the editor will wish to reproduce illustrations at the smallest practical size that allows for ready interpretation by readers. Tables should be numbered consecutively.

References: References should be cited in the text by giving the surname(s) of the author(s) followed by the date of publication for example, Jackson (1989) or (Hossain and Khan, 1992). The page numbers of all quotations should be included with the reference, for example, (Akhter et. al., 1993:14). Multiple references should be separated by semi-colons for example, (Chowdhury, 1990; Rahman, 1994). If two or more works of the same author in the same year are cited, the works should be distinguished by using the subscripts a, b, c, along with the year for example (Islam, 1991a, 1991b, 1991c). The details of all references should be listed according to the following form:
